

PRIVACY POLICY

In order to provide you with the full range of services on the site, we need to collect information about you. This Privacy Policy explains how we use and protect your data. If you have any concerns, please email info@cyprusopenstudios.com.

1. When you register as a member on cyprusopenstudios.com, we ask you for your email address, your full name and a short description of what you do. This information will be used by cyprusopenstudios.com to:
 - i. Administer your membership.
 - ii. Upload any contributions you make to the website, such as images, activity information, venue information and/or requests via the Contact form.
 - iii. Your contributions will be linked to your website entry and will be visible to everyone. Please make sure you are happy with the information you supply, and that it does not reveal personal information other than contact information about you.
2. Should you wish to make any changes to the information on your page on the website, please advise us via email to info@cyprusopenstudios.com – there is only one single administrator to the website.
3. We will not pass your information on to any third parties without your express consent.
4. All visitors to the site should please note that your Internet Protocol (IP) addresses are automatically logged by our web server. IP addresses are numbers that can uniquely identify a specific computer or other network device on the internet. We may gather information about the operating system, browser version, and the type of device you are using in order to serve you better.
5. Google Analytics collects information on your IP address but it is only used to track your visitor behaviour on cyprusopenstudios.com, and your broad location (by country). Your IP address as collected by Google Analytics cannot be used by cyprusopenstudios.com to identify you.
